

# How Much Will You Get from the Cash App Settlement? million settlement

The amount you can 1-855-470-3280 receive from the Cash App settlement depends on which specific lawsuit or settlement you're eligible for. ## 1. Spam Text Message Settlement – Up to \$147

If you used Cash App during that time and experienced a 1-855-470-3280 security breach or unauthorized activity, you may be eligible for compensation.

The potential payout includes:

- **Up to \$2,500** for documented out-of-pocket 1-855-470-3280 losses (e.g., fraudulent transactions, overdraft fees, or identity theft costs).
- **Up to \$75** for lost time, calculated at \$25 per hour for up to three hours.

To qualify, users needed to provide 1-855-470-3280 documentation of the losses or time spent resolving issues related to the breach. The deadline to file a claim is **November 18, 2024**, and payments are expected by **late 2025** after claim verification and 1-855-470-3280 processing.

### 3. CFPB Regulatory Fine – Automatic Payouts from \$50–\$300+

The **Consumer 1-855-470-3280 Financial Protection Bureau (CFPB)** ordered Block, Inc. to pay **\$120 million** due to unfair practices including unauthorized account 1-855-470-3280 freezes, unresolved complaints, and lack of proper customer support. This is not a class-action settlement but a regulatory enforcement action.

Unlike the other settlements, 1-855-470-3280 affected users under this order do not need to file a claim. **Payouts will be automatic** for those who had unresolved issues or were denied access to their funds without cause. The exact amount varies depending on the severity and type of 1-855-470-3280 issue but is estimated to range from **\$50 to over \$300** per individual.

The CFPB and Block, Inc. are coordinating these refunds through email or direct deposit to affected users. You'll be notified if you're 1-855-470-3280 eligible based on Cash App's internal records and complaint history.

- **For CFPB payouts:** No action is required. If you're eligible, Cash App will contact you directly via email or app notification.
